

**Tradewinds of Emsworth II and III – Guest Waiver of Liability**

**Please read carefully, print and sign your acceptance to the following Terms and Conditions relating to your period as a guest aboard "Tradewinds of Emsworth". The completion and signing of this document is a condition of crewing aboard Tradewinds of Emsworth II and III. Please hand the signed document to the Captain when you arrive on board:**

**Waiver of Liability:**

1. Even on a well-equipped sea worthy vessel and with best seamanship practices, risk of personal injury or loss of life is a present and real component of coastal and offshore sailing. Both guests and the skipper are entering this venture with a full understanding of the risks involved and with confidence in each other's good will and skills to meet their respective responsibilities. Having volunteered to be a guest aboard *Tradewinds of Emsworth II or III*, I fully appreciate and understand the potential for perils of sailing in coastal or offshore seas. You confirm that you are in good physical health without any impairment that could impact your ability to participate in such a voyage. By executing this waiver of liability I for myself, my heirs, successors, assigns and legal representative, hereby waive any and all claims against *Tradewinds of Emsworth*, her owner, skipper and other crew or guests and agree to hold each one of them separately and collectively harmless from any and all loss, cost, claim, damage or expense, including but not limited to attorneys fees which I may incur or which may arise directly or indirectly as a result of or out of my participation in this voyage. I have read the above terms and conditions and am in full agreement.

2. No illegal drugs or narcotics or pain killers or such like products without prescription shall be brought or consumed aboard *Tradewinds of Emsworth*, or will be purchased by guests or crew at any port of call.

3. I am aware that it is my own responsibility to pay for my flights and other travel arrangements to and from *Tradewinds of Emsworth*, including from any location should the cruise be unexpectedly terminated. Any payments aboard are made as a contribution towards the day to day running expenses of operating the vessel or as a contribution to the costs associated with the purchase of necessary supplies, such as food, drink, etc., and should not be considered as payment for any services provided.
